

Terms and Conditions



WELD Inc., dba The SANDBAR Restaurant requires a \$1000 deposit to hold any date. Five hundred dollars of deposit is refundable if cancelled 6 months prior to event date.

A confirmed number of guests and a final menu will be due 14 days prior to the event. If paying by check, the estimated bill is also due. We will expect any additional fees on the event date. If paying by credit card, the remaining balance will be expected at the close of your event. The deposit will be applied to the balance due. If attendance exceeds the confirmed number of guests, the quoted price will be paid for each additional guest. The SANDBAR will prepare for approximately 10% above the guarantee.

In accordance with the City of Anna Maria sound ordinance, all amplified music must be volume controlled and end at exactly 10:00 PM. There are no exceptions. All musicians must be approved by the Sandbar before the date of event.

Each of our events has a spending minimum for food and beverage purchases. This minimum charge varies depending on the time of day, the day of the week and the season of the year. Our event planner will explain the minimum food and beverage expenditure required for your specific date and time. Food and beverage minimums do not include the sales tax or gratuity revenue. All food and beverage is subject to the current Florida State sales tax (6.5%) and a 20% gratuity unless otherwise stated.

The SANDBAR is the only licensee authorized to sell and serve liquor, beer or wine on the premises. Therefore, **NEITHER PATRONS NOR THEIR GUESTS WILL BE ALLOWED TO BRING ANY OUTSIDE ALCOHOL OR ALCOHOLIC BEVERAGES ON THE SANDBAR PREMISES.** Also, to ensure the safety of all our guests and comply with local health regulations, neither patrons nor their guests shall be allowed to bring food into the event area. We are at your service to accommodate your special requests and to ensure the success of your event. Food may not be taken from the event area and buffet lines will remain open no longer than 2 hours.

In the event of SEVERE weather conditions the SANDBAR reserves the right to cancel an event with a 24 hour notice. Events cancelled by either party due to SEVERE weather conditions are subject to a full refund of the deposit or re-scheduling of the event date depending on availability. In the case of heavy rain all scheduled activities will be moved under the Pavilion.

Confetti and/or table sprinkles of any kind are strictly prohibited. **FIREWORKS ARE STRICTLY PROHIBITED** on the beach or Sandbar property. The lighting of Sparklers is allowed EXCEPT for under any type of structure and during Turtle Season. Real flower petals must be used on beach for ceremony. Silk flowers may be used under the pavilion.

May 1 - October 31 is Turtle Nesting Season. Lighting on the beach and under the pavilion must be kept to a minimum. Lights that you may have seen used in the off season are not approved for use during Turtle Season. The Sandbar must comply with state and local laws regarding endangered species.

The SANDBAR reserves the right to book more than one event on any given date.

The SANDBAR has permission to take pictures or videos to be used for advertising.

The SANDBAR assumes no responsibility for any property brought on or delivered to the event site by guests, contractors or vendors.
